Dear Grant Applicant:

Thank you for your interest in the Buddy Christian Foundation. Our mission is to prevent law enforcement line of duty deaths and assist the surviving family members of law enforcement officers killed in the line of duty. One way we accomplish our mission is to provide police officers with versatile, purpose-built, compact, personal, self-aid capable, first aid kits that we have named Buddy Kits. These Kits are equipped for point-of-wounding treatment of traumatic injuries that could result in line-of-duty deaths if not treated immediately.

If your agency cannot afford to purchase all of your police officers Buddy Kits at the full retail price, the Foundation may subsidize your purchase.

Please take a moment to review the following pre-qualifications.

1. Only applications submitted by law enforcement agencies will be considered.
2. Only first-party applications will be considered - your application must be a direct request.
3. Agencies must wait a minimum of one year from their last reviewed application before submitting an additional application.

Your application will not be considered for funding unless all necessary information is included. Please complete all of the fields on the Grant Application, and include the following attachments:

- Background information on your agency and city, to include a brief history of your agency;
- Your agency's most recent financial information (examples include financial statements, operating budget, or bank statements).

- 1. This applicant agency pledges to deliver its share of Buddy Kit funds to the Buddy Christian Foundation upon being notified this application is approved. The agency understands that Buddy Kits will be shipped only after receipt of applicant agency's funds.**
- 2. Any Buddy Kits this applicant agency receives will be distributed into the field of operations upon receipt.**
- 3. Any Buddy Kits this applicant agency receives will be distributed based on at-risk need. The most at-risk organizational units in this agency will receive Buddy Kits first. The least at-risk organizational units will receive Buddy Kits last. High-risk special operations units (SWAT, SRT, Fugitive Task Force, Drug Task Force, etc.) and patrol officers will receive kits first. Investigators and administrative staff will receive kits last.**
- 4. Any time a Buddy Kit this applicant agency receives is used to treat traumatic injuries, this applicant agency will submit a report summarizing the circumstances surrounding the kit's use to the Buddy Christian Foundation. The applicant agency understands that the Foundation uses these summary reports to make an assessment of the effectiveness of the Buddy Kits Grant program.**
